GrainCorp Shipping Stem 2026/27 Season

1. 2026/27 Season Shipping Stem

GrainCorp will open its Shipping Stem at **10:00am AEST** on the **14th of July 2026** for the Shipping Period 1 October 2026 – 30 September 2027. Due to contracted capacity commitments at Exempt Port Terminals, Elevation Capacity at Exempt Port Terminals during this period will be limited. Elevation Capacity will be allocated in accordance with the terms and conditions of the applicable Port Protocols.

Elevation Capacity obtained through this process will be subject to signing and returning a GrainCorp Bulk Wheat and Non-Wheat Port Terminal Services Agreement for 2026/27 prior to submitting nomination applications. Please note that the vessel nomination booking fee for 2026/27 accepted nominations will be \$10.79 per metric tonne, all other port terminal fees will be as per the 2026/27 GrainCorp Bulk Wheat and Non-Wheat Port Terminal Services Agreement, which has been published on the GrainCorp website.

To support efficient access for chickpea exports and in response to anticipated high demand for chickpea exports during October to December, GrainCorp will be accepting Chickpea nominations only for Elevation Capacity at Mackay and Gladstone during the Shipping Period 1 October 2026 to 31 December 2026. This is to help facilitate shipments to meet importing timeframes of major export markets. Nominations for Elevation Capacity for other commodities (including chickpea) at Mackay and Gladstone will remain available from 1 January 2027. Should this situation change, GrainCorp will notify exporters promptly.

In line with how Elevation Capacity was managed at Port Kembla for the 2025/26 season, all Elevation Capacity for 2026/27 season at Port Kembla is being offered on an 'On Application' basis due to NSW Ports infrastructure works on Berth 104 impacting available capacity. GrainCorp is working with NSW Ports to minimise this impact however is unable to definitively offer capacity as "Available".

2. Short Term Elevation Capacity

The below table outlines the short-term elevation capacity in metric tonnes that will be available for nomination at Non Code Exempt ports and whether capacity is available for nomination application at Code Exempt ports. Please note that the Elevation Capacity is presented in half months. GrainCorp may update elevation capacity available for nomination if required, and will inform exporters accordingly if any changes occur.

Cargo Nomination Applications (CNA) will be available for submission from **10:00 am AEST** on the **14th of July 2026** and if you wish to nominate, the CNA workflow URL address for the application is available at:

Each customer (inclusive of related entities) will be allowed up to seven (7) individual log-ins to GrainCorp's CNA Workflow system. To ensure our records are aligned with the users who are planning to access and enter CNAs in the CNA Workflow, please nominate the individuals you wish to have access to the CNA Workflow by emailing george.keeping@graincorp.com.au by the close of business **6th July 2026**.

Elevation Capacity will be allocated to customers in line with the applicable Port Protocols. In anticipation of updates to the regulatory framework for Bulk Wheat Exports, GrainCorp may update the Port Protocols to align with any revised port elevation capacity frameworks. GrainCorp will consult with exporters promptly should this change occur.
