## **INSTRUCTIONS**

GrainCorp can process your <u>Grower to Grower transfer requests over the phone.</u> If you have your transfer requested over the phone, you will <u>not</u> have to complete this form.

You can take advantage of this service by calling 1800 GRAINS (1800 472 467).

- 1. As the Grower/Seller You must complete sections A, B and C.
- 2. To transfer to a Grower/Buyer, you must nominate individual receival dockets
- **3.** You as the Grower/Seller must sign section C and email this for to the GrainCorp Grower Services Department. If an agent/third party is acting on your behalf, a completed Appointment of Agent form must be active. You, the Grower, MUST be a listed contact on the NGR account.
  - **Note:** Please keep a copy of the email that you send for your records.
- **4.** Subject to verification, GrainCorp will execute the transfer. The effective date of transfer shall be the date on which the Grower's signed copy of this Grower to Grower Title Transfer Form is received and processed at the GrainCorp Grower Services Department.
  - You will receive return communication from the GrainCorp Grower Services Department, either confirming the transfer has been processed and completed, or if there is additional information required.
